on NO:GH/SH/5/2015/SCT/1310/599/GH:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Head of Department in Engineering or Technology in different disciplines, in Gujarat Educational Service, Class I (Collegiate Branch) Recruitment Rules, 2012, namely :-

- These rules may be called the Head of Department in Engineering or Technology in different disciplines, in Gujarat Educational Service, Class I (Collegiate Branch) Recruitment (Amendment) Rules, 2015.
- In the Head of Department in Engineering or Technology in different disciplines, in Gujarat Educational Service, Class I (Collegiate Branch) Recruitment Rules, 2012 (hereinafter referred to as "the said rules"), in rule 2, in clause (a), -

(i) in the proviso, under sub-clause (ii), the word "or" shall be deleted;

(ii) after sub-clause (ii), the following sub-clause shall be added namely:-

"(iii) possess educational qualifications as prescribed in sub rule (b) of rule 3; or"

- 3. In the said rules, in rule 3,-
  - (I) in clause (a), for the figures and word "40 years", the figures and word, "42 years" shall be substituted;

- in clause (b), in sub-clause (i), for the word " equiring", the (II)word, " acquiring" shall be substituted.
- in sub-clause (ii), for the words, "and have atleast ten years (III) relevant combined or separate ten years relevant combined or separate experience in teaching or research or industry; after ecquiring Master's Degree", the words "and have atleast ten years relevant combined or separate experience in teaching or research or industry after acquiring Master's degree." shall be substituted.

No.GH/SH-17/12/SCT/1310/599/GH:- In Exercise of the powers of conferred by the proviso to article 309 of the Constitution India and in supersession of all the rules made issued in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Head of Department in Engineering or Technology, in different disciplines, in Gujarat -Educational Service, Class I (Collegiate Branch) in Government Polytechnic under the Directorate of Technical Education, Gujarat State, namely:-

HOD Clobytechnic,

These rules may be called Head of Department in Engineering or Technology in different disciplines, in Gujarat Educational Service, Class I (Collegiate Branch) Recruitment Rules, 2012.

Appointment to the post Head of Department in Engineering or Technology in different disciplines, in Gujarat Educational Service, Class I (Collegiate Branch) in Government Polytechnic shall be made either,-

(a) by promotion of a person of proved merit and efficiencyfrom amongst the persons who,-

(i) have worked for not less than eight years in the cadre of Lecturer in the Gujarat Engineering Service, Class II (Collegiate Branch) in Government Polytechnics under the Directorate of Technical Education; and

(ii) have passed the qualifying examination for computer

knowledge in accordance with the provisions of the Guj. Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that where the appointing authority is satisfied that a person having the experience specified in sub-clause (i) above is not available for promotion and that it is necessary in the public interest to fill up a post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a period of not less than two-thirds of the period specified in sub-clause (i) above; or (b) by direct selection.

3. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall,-

(a) not be more than 40 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) rules, 1967.

(b) possess,-

(i) a Ph.D. Degree or equivalent degree in appropriate branch of Engineering or Technology with 1<sup>st</sup> Class at Graduate or Post-graduate level from any of the universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or deemed to be a University under section 3 of the

University Grants Commission Act, 1956 and recognised by the All India Council for Technical Education and have atleast five years combined or separate experience in teaching or research or industry before or after equiring <u>uching</u> Ph.D. degree; or

(ii) a Bachelor's and Master's degree in appropriate branch in

Engineering or Technology with first class either at Bachelor's or Master's level from any of the Universities established or incorporated by or under the Central or State Act in India, or any other educational institution recognised as such or declared as deemed to be University under section 3 of the University Grants Commission Act, 1956; and recognised by All India Council for Technical Education and have atleast ten years relevant combined or separate ten years relevant combined or separate experience in teaching or research or industry; after equiring Master's Degree.

(c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

(d) possess adequate knowledge of Gujarati or Hindi or both.

Explanation:.-

(i) In case of research experience, good academic record and books or research paper publication/Intellectual Property Rights (IPR) or patent record shall required as deemed fit by the Gujarat Public Service Commission.

(ii) If the experience in industry is considered, the same shall be at managerial level equivalent to the post of Lecturer in Government Polytechnics recognised as such by the

government with active participation record in devising, designing, developing, planning, executing, analyzing, quality control, innovating, training, technical books/research paper publications/intellectual Property Rights (IPR)/patent etc. as deemed fit by the Gujarat Public Services Commission.

(iii) Equivalence for Ph.D. is based on publication of 5 international journal papers, each journal having a cumulative impact index of not less than 2.0, with incumbent as the main author and all 5 publications being in the author's area of specialization.

(iv) If a class or division is not awarded, minimum aggregate60% marks shall be considered equivalent to first class ordivision.

(v) If a grade point system is adopted the Cumulative Grant Point Average (CGPA) shall converted in equivalent marks shown as below:-

Grade Point	Equivalent Percentage
6.25	55%
6.75	60%
7.25	65%
7.75	70%
8.25	75%

- 4. The candidate appointed by direct selection shall be on probation for a period of two years.
- 5. The candidate appointed by direct selection shall, during his probation period, be required to undergo pre-service training

and to pass the post training examination in accordance with the provisions of the Gazetted Officers' Pre-service (Training, and Examination) Rules, 1970.

- 6. The candidate appointed by direct selection shall, during his probation period, be required to pass qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency (Training and Examination) Rules, 2006.
- 7. The candidate appointed by direct selection shall require to pass an examination in Hindi or Gujarati or both in accordance with the rules prescribed by the government.
- 8. The candidate appointed either by direct selection or by promotion shall have to undergo such training and to pass such examination as may be prescribed by the Government.
- 9. The candidate appointed by direct selection shall require to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
